*The GCPS School Board has set the parking fee to \$75.00 per school year.*

*To obtain a student parking decal, please adhere to the following instructions:*

1. *The registration itself must be completed in full and signed by all designated persons. Incomplete forms will be returned*
2. *The applicant must be in good standing at Goochland High School and all student fees (including the parking fee) must be paid in full prior to registration acceptance and parking tag issuance.*
3. *Enclose a check or money order made payable to "Goochland High School" for the designated amount*
4. *Upon receipt and acceptance of your registration and payment, a student parking decal may be picked up from Taylor Snow, GHS Assistant Principal*
5. *Once registration is accepted and parking tag is issued, all registration fees are non-refundable.*



Goochland High School 2017-2018  
Parking Rules and Regulations



1. The privilege to park at GHS is considered conditional, and is contingent upon the following conditions:
  - a. The student must be, and remain, in good financial standing with Goochland High School.
  - b. The student must purchase a parking tag valid for the 2017-2018 school year OR for spring 2018 only and display the tag on the registered vehicle's rear view mirror. Vehicles that fail to display the tag properly will receive a violation commensurate with parking an unregistered vehicle.
  - c. All registered vehicles must conform to all state and local laws.
  - d. The student, student's parent(s) or guardian(s), and the registered owner of each vehicle registered to park at GHS must agree to a search of said vehicle at any time, should the school administration have reasonable suspicion to invoke a vehicular search if it is believed that the student has an illegal substance, weapon, or any other item in violation of state law and/or the policies and regulations of Goochland County Public Schools.
  - e. A student's privilege to park at GHS may be temporarily suspended or permanently revoked if disciplinary action is undertaken as a result of student misconduct or other referral actions. Such temporary suspension or revocation of parking privileges may be exacted in addition to other administrative sanctions.
  - f. Students may not alter, trade, or transfer parking tags to any unregistered vehicle. Changes to parking registration should be made with Mr. Snow.
  - g. The playing of loud music and unsafe or reckless driving is prohibited and can result in the suspension of parking privileges.
2. There must be no loitering in or around parked vehicles at any time. Students must leave their car immediately upon arriving to school and must leave the parking lot immediately upon dismissal at the end of the day. **Students will not be allowed to return to their vehicle during the school day for any reason without administrative permission. Any student doing so without administrative approval will be subject to search and/or other disciplinary actions upon re-entry to the building.**
3. Goochland High School and Goochland County Public Schools are not responsible for vehicles nor their contents while parked on school property. The school is not responsible for acts of vandalism or theft in the parking lots. All acts of vandalism or theft should be reported immediately to the School Resource Officer (SRO).
4. **Any student who maintains GHS parking registration and skips class, or aides another student in skipping class, is subject to disciplinary actions up to and including a suspension or revocation of driving privileges by school administration.**
5. Similarly if a student is excessively tardy to school (4 or more tardies per semester), the student is subject to disciplinary actions by school administration including the suspension or revocation of parking privileges.
6. Failure to comply with any of the aforementioned rules, regulations, or expectations above may result in a suspension and/or revocation of driving privileges for the duration of the school year by administration.
